

SPECIAL EVENT REQUIREMENTS FOR THE TOWN OF MEDLEY

A Town of Medley Special Event Permit is required for any event, which takes place on public or private property. The Special Event Application form must be completed and submitted not less than ten days in advance. A Special Event may not be held unless it has been approved by the Building Department pursuant to the procedures set forth below and in the attached application.

The requirements for a permit are:

- 1. Completed application and a non-refundable permit fee, pursuant to the town's fee schedule.
- 2. Certificate of Insurance.
- 3. Site plan of event showing all temporary installations in relation to the surroundings. The site plan must show a detailed diagram of the event including the location of concession booths, portable toilets, dumpsters, public, emergency and accessible routes, parking banners and signs, tents, location of stages and entertainment and orientation of loudspeakers, locations for electricity and water, and other relevant information.

The person in charge of the event must be present at the event and remain at the location for the entire duration of the event.
